Offshore Securities Trading Service Restriction for Foreign Investors from Restricted Countries

As Bualuang Securities Public Company Limited (the "Company") provides offshore securities trading service through the foreign securities trading systems, Global Invest and Global Trade Master, which operated by foreign service providers, these providers have a policy to restrict services for foreign investors from countries designated as "Restricted Countries".

To comply with such policy, the Company hereby informs that it is necessary to restrict the provision of offshore securities trading services and/or the opening of offshore securities trading accounts for foreign investors who utilize offshore securities trading service through the foreign securities trading systems, Global Invest and Global Trade Master, and who are residents of, are nationals of, or whose sources of funds originates from the Restricted Countries, as listed on the list attached to this announcement.

This announcement shall be effective from 1st July 2025 onwards.
